Well, now that the time has come, I would like to start the Reiwa 5th Nara Institute of Science and Technology Alumni Association General Meeting.

Well, my name is Kiyokawa, and I am serving as the chairman. Thank you. Yes, um, do you have the documents you have? Well, please share the materials with the administrative staff.

Participant 1 01:54

Yes, um, this is the document. Yes, let's proceed. Once again, um, ah, um, well, everyone, ah, thank you for being here. Yes, um, well then, we will move forward with the agenda in order, um, but first, we will review the summary of the previous general meeting.

Eh, here are documents 1 and 2, er, last time, er, last year's, er, the summary of the alumni association general meeting.

Participant 1 02:19

If you have any concerns, please let us know by the end of this general meeting. Yes, um, and we're going to deliberate from now on, but first, um, I'd like to make a proposal, um, this time, um.

Participant 1 02:40

Well, we are holding a hybrid general meeting, but, um, the majority of people are unable to attend.

So, uh, well, that's a total of 11,000 people including master's degrees, uh, doctoral degrees, and uh, there are only a very limited number of people who can participate in this general meeting. So, um, we're going to have some deliberations, um, from now on.

Participant 1 03:00

Um, this is provisional, uh, approval, but the actual final approval will be, um, by sharing the recording of this general meeting with our members online. After confirming that, I will, of course, share the deliberations.

Participant 1 03:19

Well, after that, about two weeks, um, about a month, um, I'll adjust the timing again, um, with enough time, um, anytime, uh, I will ask you to look at the contents of the general meeting and make your own decisions, so I will ask you to complete a questionnaire and ask for everyone's approval. Well, please approve or disapprove.

Participant 1 03:39

Well, I would like to make decisions on individual matters. Well, with this way of proceeding, and that way of proceeding, only the people currently present can get a majority vote. What do you think?

Thank you. Yes. Well, actually, I already tried that the year before last, and it was well received, but last year, due to my laziness, I couldn't do it a bit, so I'd like to revive it.

Participant 1 04:03

thank you. Well, in that case, I would like to start with the first item for discussion. Well, this is the first item to be discussed.

Participant 1 04:21

Well, it's about the financial results, um...

Participant 1 04:30

It's from document 2. Eh, income and expenditure report for FY2020, erm, and document 3 is the accounting audit results report. Eh, there are these two items, so regarding document 2 and document 3, erm, I would like to ask a vice chairperson Kobayashi, who is in charge of accounting, to explain.

Participant 2 (Vice Chairperson Kobayashi) 04:45

Thank you. This is a vice chairperson Kobayashi. I will not read what is written to avoid waste of time by repeating them. I would like to point out 2 things I want to let you know.

First, the monthly usage fee for PalSyne is currently 26,950 yen. This pricing is based on the initial contract with the company 4 years ago. But consumer prices are getting high in general and based on the company's website currently shown, it would probably cost 37,400 yen/month. So starting next year,

Participant 2 05:15

The price may increase. Because we've already received receipts for this fiscal year (R4), I don't think they will charge more for the past service but future price hike is likely.

Second, in this fiscal year (R4), we actually sent condolence telegram for the passing of Ms. Sachiko Iida, who had a significant contribution for NAIST, especially for her strong support for students from Indonesia. We also agreed to support alumni gathering for celebrating Prof. Kunio Yasuda's (former president of NAIST) 80th birthday.

Participant 2 05:39

Because they happened very close to the end of fiscal year, we were not able to make the payment in time for the fiscal year which ended in March 2023. These 2 payments will be made in the next fiscal year.

Related to the above issue, I would like to propose one thing about payment.

Participant 2 06:03

When we make a bank transfer about 2,000 yen to somebody, we have to pay several hundred yen in transfer fees. We hesitated to pay the extra cost, and we tried to withdraw money from bank and hand it to Director Okamura (who made advanced payment) because both he and Chairperson Kiyokawa work on NAIST campus. But withdrawing money was not easy for

Kiyokawa because Nanto Bank ATMs are not conveniently located. It was one of the reasons why the payment was delayed.

Participant 2 06:26

So, from fiscal year R5 and onward, regardless of the recipient or amount of money, we would like to make "bank transfer" the first choice.

That's all for me.

Participant 1 06:41

Thank you very much. I think the last part (about transfer fee) was a report and a proposal. Kobayashi suggested that we should avoid paying or receiving cash, as much as possible, and settle it by wire transfer in the event somebody made advanced payments. For my part, I welcome the idea and I am very grateful for the proposal. I will list this issue for online discussion.

Participant 1 07:04

But at the moment (in this room), do you have any opposing opinions? OK. It seems that people here generally agree with the proposal. I will include the issue for the agenda for online discussion.

Is that all for the accounting report? OK, thank you. Well then, let's move on to document 4.

Participant 1 07:26

Well, regarding the activity plan, Kiyokawa would like to report on it. Um, materials, um, yes, um, next. Here it is. Yes, thank you.

Well, regarding Document 4, uh, activity plans, we will be planning the budget for this year, 2020, and 2020. Well, here's a suggestion about that.

Participant 1 07:55

So, uh, what kind of policy have we followed? Well, we haven't finished the financial statements for the current fiscal year, uh, so last year, uh, Reiwa 4th year, in other words, uh. Um, thinking about the budget, um, from this point on, we're proceeding with a plan that is based on the actual income from two years ago, and that the expenses do not exceed that amount.

Participant 1 08:17

Well, that way, um, you can have a plan that won't break the bank for many years.

So, uh, I'm writing about the enrollment rate of new students, but this is, um, every year, um, um, um, um, it's a plan, or rather, a push. Well, I'll skip this part, but please take a look at the table below. First, let's look at the income section.

Eh, this is, as I said earlier, starting from FY2023, the actual revenue results for FY2020, two years ago, are as reported earlier. Well, there were 6 people from Nanto Bank, 250 people from Japan Post Bank, and membership fees from Eno. Plus, there was interest on Nanto Bank, so income was a total of 5.12 million yen, or 18 yen.

Participant 1 09:00

So, um, we are planning our spending this time to match this, so this is a proposal.

Well, let's start from the top. yes. There was a lot of talk about the amount being for Palsain, but I've set it up with this, so it's not that big of a difference, so it's roughly 300,000 yen. Also, Nanto Bank's online banking.

Well, on the third line, there's something about administrative staff employment costs, and this has been a topic that's been smoldering for a while, but at the moment, the student support staff is very, um, Thanks to the support we have received, things are going well for now.

Eh, line 4, the cost of creating a diploma folder, erm, this was last year, erm, it was started last year, erm, it's a measure that we started.

Participant 1 09:40

Eh, well, on the back of the diploma, erm, master's degree, doctoral degree, erm, it says ``Alumni Association Donation'', erm, we're paying for it, so that's pretty much it. 600,000 yen. Next, from the 5th line, um, uh, the expenses related to the reunion, uh, sponsored events or support events are listed, uh, these 5 lines. Regarding eyes,

Participant 1 10:06

Eh, well, homecoming day, erm, well, I think it's about time to include support for food and drink expenses on homecoming day, erm, as we used to do. , is placed in the 5th line.

Also, regarding line 6, erm, there are also various events sponsored by the alumni association. So, we asked if we could pay the invitation fees and honoraria to the lecturers, and we have set aside 30,000 yen for each of the three lecturers.

Participant 1 10:32

Well, below that, there are two lines, it says 100,000 yen, 50,000 yen, 5, 10, etc. for support expenses for holding reunions. Well, the support fee for holding a reunion is 2000 yen per person.

So, uh, we're going to support up to 50 people, up to a total of 100,000 yen, so we're asking everyone to raise their hands.

Participant 1 10:56

Um, well, I'm currently encouraging them, but I think there are about 5 of the largest ones, and 10 of them, with about 25 people. So, in total, I have accumulated 1 million yen.

Well, looking at this year's results, it may still be, um, a bit too much, but I'm hopeful that it will gradually recover.

Well, below that, it says 50,000 yen for overseas branch activity support expenses, INAA.

Well, there are, um, several overseas branches here, but in particular, the Indonesian alumni association branch has been, um, very active for many years. Well, based on that, uh, overseas, uh, alumni association branches,

Well, a certain number of people are active, and they hold something like a general meeting at least once a year. ,Eh, well, depending on that kind of thing, 10,000, 20,000, 30,000, 40,000 up to a maximum of 50,000 yen,

Participant 1 12:00

This is a measure that we started last year to give you activity support funds that you can use as you wish.

So, um, this person also wants to save money for next year as well.

Um, well, considering the actual situation regarding support costs for overseas branches here, uh,

Participant 1 12:22

There may be an argument that it's okay to burden them even more. As a matter of fact, we would like to know more about the Indonesian branch, um, specifically how much expenditure is actually being incurred, or if we can provide a little more support, if we can get it, we would like to do this and that. I guess you're thinking about it.

Participant 1 12:41

Well, we decide on the amount without much adjustment in those areas. So, uh, I'd like to make some additional suggestions, uh, sorry for confusing them, but uh, regarding support for the activities of overseas branches, I've done a little research on the actual situation. I think there are some people who think that it would be okay to increase the maximum amount a little more than 50,000 yen, so if you increase that amount, erm, uh, depending on the actual situation of the activity,

I would like to, um, investigate whether it would be okay to increase the upper limit a little more, and, um, I would like to, um, discuss it again here . If it is reasonable, I would like to have another discussion about taking such measures, such as increasing the amount from 50,000 yen to, say, 80,000 yen or 100,000 yen.

Participant 1 13:33

yes. Well, the next thing is, um, there is a support fee for holding a welcome party for new students.

Eh, this is also one of the measures that, erm, we haven't been able to implement very often, but in April, erm, when new students arrived, erm... We'll have a little party, uh, welcome party that involves some food and drink.

Participant 1 13:53

Well, I'd like to plan a way to have some interaction.

And, uh, other things, this one costs, uh, uh, various things, so there's also the transfer fee and, um, uh, I'm writing it all together, and it's about 30,000 yen. , Yes, this is roughly half of that income. So, as for contingency funds, future web renovations and other savings, especially when it comes to web renovations, can cost several million yen all at once.

Participant 1 14:21

Well, I'm wondering if it's necessary to set aside money for this, so this is the current budget proposal.

So, um, I would like you to go through the online process I mentioned earlier and deliberate on this budget bill, which will ultimately take several weeks. Masu.

Um, does anyone here have any opinions?

Participant 2 14:45

I have a question for you. For the past 2 years, the event hosted by the alumni association were held online, so I don't think there was any compensation, but this year, yesterday, 3 people made presentations (on site), I think. So, the amount is exactly like this, um, 30,000 yen times 3?

Um, uh, as you said, uh, yes, um, in the case of honorariums, uh, you pay, whether it's online or not, and if there are travel expenses, well, we can support both. I'm sure there are some, but what I'm writing here is, erm, I imagined the invitation fee to be travel expenses, so I'm going to mix it up with the invitation fee and the honorarium. So, it says it's about 30,000 yen per person, but actually, um, I haven't thought about it strictly, but if travel expenses are incurred,

Um, I think there's a point where, after covering the travel expenses, the honorarium can't be reduced just because of that. I think the reality is that the amount changes a little here.

Do you have any opinions regarding the FY 2020 budget proposal? Well, I haven't been able to pick up any opinions from people online.

Well, if you have any opinions, you can chat or, uh, raise your hand. Well, you can just say it as is.

There are almost no people online.

Participant 1 16:20

yes. Well, if you need anything else, I'd like to come back anytime. Well, I hope you can interject.

Um, if you do that, then, um, um, um, uh, you can see below in this document 4, and I'm going to read the next one, but um, I also write about measures to increase membership every year.

Where is it? Oh, please. Yes Yes Yes.

Um, it's not about the content, but Mr. Sugimoto, who is a former material expert, is he participating now?

Um, it's in. Yes, thank you. Oh, sorry, I just wanted to confirm that.

Excuse me. Yes, um, I recognize that. Um, uh, I think you'll have to say something later. Yes, thank you very much.

Yes. Well, let me continue. Well, then, it's the same document 4, uh, the middle part. Well, regarding measures to increase membership, you see, we need to recruit alumni to join.

Well, as for new students, well, um, a certain percentage, not all of them, but a certain percentage, have been able to join every year. However, as far as the past is concerned, we haven't been able to unearth it at all, so here are some examples of how some directors are working hard individually. However, as an alumni association, we have not been very active.

So, you know, uh, what's the problem? Basically, you have to do everything online, uh, to sign up, so it's a difficult process to verify your identity. There is. Up until now, that part had been covered by the Student Support Section, but in earnest, hundreds, thousands, uh, people were joining all at once. If you try to do this, you'll get a flat tire, so what should you do?

So, uh, since around last year, I think most of the laboratories, uh, have been keeping and managing names on a lab-by-laboratory basis, so, um, there's an e-mail address that can be used to verify your identity. There was an opinion raised about whether we could make better use of it. So, uh, in terms of matter, uh, actually, uh, you're doing a little bit of activity.

Well, it's still a little, t-way in the process, so I won't give out detailed information here, but, uh, I've made a request to about 1,000 people, and it's not a class reunion. I will post it to the research group's mailing list.

Well, if the person who receives it agrees with his or her own will, the system is such that he or she takes action to join.

So, this is a system that eliminates the step of identity verification. So, uh, using that system, we've had about 1,100 people approach us, and now we've got about 150 people joining.
